Shaping the Catholic agenda

As the Herald surveys the top 250 US Catholic influentials, William Cash explains how Catholic leadership has passed from the clergy to the laity and philanthropists

> here is a crisis of Catholic identity in America. The torch of Catholic leadership is now in different hands than a generation ago. While America's Catholics may be divided

into rival political and factional tribes, what brings our cast of influentials together is a shared concern over Catholic values.

Nowhere is this more evident than in Catholic education. Indeed, to understand why we are launching our new US Catholic leaders special report – celebrating the top 250 Catholics helping to shape American society for the better – we can start with a visit made last November to the Rochester, NY, campus of the Aquinas Institute by its old alumnus, the financier Robert Agostinelli

Through hard work and "God's graces", and guided by the Catholic values instilled in him as a student at Aquinas, Agostinelli, 69, has built the Rhône Group into a highly successful private equity company. He had been thinking of giving a significant gift to his old Catholic high school, where he served as an altar boy at local Masses celebrated by Bishop Fulton J Sheen, host of the award-winning television show Life is Worth Living. "Father Sheen" featured on the cover of Time in 1952 as one of America's key post-war spiritual leaders.

The weekend invitation included the opportunity to return to the high-school football ground where Agostinelli had enjoyed success as a player back in the 1960s. But by the time the match was due to start, he and his wife had been disinvited by the trustees from attending the school match. This was due to some student sensitivities

being ruffled by a (well-received) speech about

identity subverted with progressive and secular values in which students were being forced to genuflect to political correctness and "endure a tyrannical command to follow woke sufferance in every form".

"After I spoke out, I could have gone on a global lecture tour as I had so many speaker invitations," Agostinelli told me over lunch. "It opened my eyes to the crisis of Catholic identity in America, especially in education. Leadership now has to come from outside Catholic institutions, and lies increasingly with lav leaders."

Catholic leadership is today passing from the Church and Catholic institutions to the lay community, particularly led by active members of the Order of Malta, the Knights of Columbus and the Equestrian Order of the Holy Sepulchre of Jerusalem, along with US business and philanthropy leaders determined not to let Catholic values slide.

This is a view shared, with sadness and regret, by Father Gerald Murray, author and *Herald* writer who is parish priest at the Holy Family Church in Midtown Manhattan and a member of EWTN's Papal Posse. With the 60th anniversary

of the Second Vatican Council this October, Fr Murray says that one of its most notable effects has been the emergence of the Catholic laity in "educating, inspiring and analysing the faith" – a role in American Catholic public life usually taken on by theologians and spiritual leaders such as Sheen, Cardinal Francis Spellman - the anti-communist confidante of Pope Pius XII who founded the Al Smith Dinner for New York Catholic charities - and Father Charles Coughlin, the anti-Prohibitionist so-called "Radio Priest" who amassed over 30 million listeners in the 1930s.

Today, alas, fewer priests are at the forefront of cultural and public debate. One London event that was cancelled because of the Queen's death was an address by Bishop Robert Barron in the Palace of Westminster on the subject of "What Christianity brings to the public conversation". Barron, the founder of the Word on Fire Ministries, operates largely online via his YouTube and social media channels.

In short, with some notable exceptions. such as the charismatic Cardinal Timothy Dolan of New York, equally at home in the Bronx as the Upper East Side, outspoken Los Angeles archbishop José Gómez and America's newest Cardinal Robert W McElroy, priests are increasingly invisible on the public stage. The lay patron saint of this shift was William F Buckley, Catholic founder of the National Review.

His TV debates with Gore Vidal were as celebrated as the BBC headto-heads in 1948 between Jesuit priest Frederick Copleston and Bertrand Russell about the existence of God.

"As a cleric, I regret to say that most of the most brilliant thinkers in the Catholic world now are not amongst the clergy," Fr Murray told me at his New York rectory. "The laity are providing the most incisive analysis. Having a magazine such as the Herald, where they can publish and have their views disseminated is wonderful. Sadly, many of the clergy either have no interest in intellectual life or don't really want to defend the doctrine of

the faith. But there are plenty of laity William F Buckley who are most willing to do that."

> These range from individuals helping to fund new "classical" Catholic private schools in Philadelphia, like the six Regina Academies, whose executive director Mark Bradford is profiled, to the actor Mark



Wahlberg who, in a Herald interview, said he often gets up before 3am to pray. Across America, philanthropists, business leaders, entrepreneurs, CEOs, politicians, thought leaders, lawyers and justices are influencing society and helping to renew Catholic identity.

When we launched the *Herald* in the US in 2018, we wrote a waspish cover story called "Meet America's Catholic Tribes". While there remain bitter divisions between Team Francis and the Benedict XVI camp's social conservatives, what our new survey shows is that you cannot stereotype America's Catholic landscape into two camps: "trad" conservatives and progressive liberals.


Catholic America is a big tent of all political colours, factions and creeds. Many right-wing Catholics, for example, have no time for Latin Mass. "As for the Holy Father, some conservatives recoil at the mention of his name," we noted. "Others are worried by his pontificate, but won't tolerate personal criticism of the Successor of Peter."

President Joe Biden has a photo of Pope Francis in the Oval Office. Although we have reservations about Biden's brand of Catholiclite faith, Catholic leaders today are making an impact in government and public space. Catholic social teaching now sets the moral tone of public discourse in America, helped by op-eds in the Wall Street Journal, whose columnist Bill McGurn is profiled. No less than six Supreme Court justices are Catholic. But not all Catholics - especially women - are overjoyed by the overturning of Roe v Wade.

As our entries testify, the University of Notre Dame continues to be the main formation ground for shaping future Catholic leaders (a Notre Dame intern helped with our research). In 2016, controversy followed when pro-choice Biden was awarded Notre Dame's famed Laetare Medal, regarded as the highest Catholic honour in the US (John F Kennedy received it in 1961). Still, the recent news that Marcus Freeman, head coach of the Fighting Irish's football team, has converted to the Catholic faith, suggests that the university's Catholic leadership credentials are as strong as ever under president Father John Jenkins. Notre Dame has \$18 billion of endowment, a large proportion being alumnae donations. So, what are our criteria for inclusion? We have taken a broad church approach to reflect the reality of Catholic America today. Even if

some of our entrants don't openly identify as Catholics – and some would admit to being far from sainthood – their lives have often been shaped by their Catholic background (often Irish or Italian) and faith. They want to be a force for good and give back.

Our survey is launching at the same time as our non-profit Catholic Herald Institute, whose goal is to defend Catholic values in public life and uphold the pillars of Catholic faith: family, human dignity, and protecting life. We also believe in upholding a collective Western tradition of culture and faith. The aim is to use our think-tank as a funnel for ideas for our affiliate 134-year-old magazine and our website. While there are numerous

Catholic institutes, not one has a platform like the Herald's to influence public debate and the future of the Church.

For today's Catholic leaders, donating to their local church and community is not enough - they want to make a difference politically. Sean Fieler, president of Equinox Partners, is proactively influencing public discourse and policy on issues such as strengthening the family, abortion and gender identity. Agostinelli has been chairman of the National Review Institute and instigated the William F Buckley prize for leadership in political thought. This year it was awarded to Larry Kudlow, the TV host, former Ronald Reagan treasury adviser and Catholic convert.

Ultimately, what drove Bishop Sheen who was proposed for beatification by Pope Benedict XVI - was a desire to see Catholic identity and its moral purpose flourish in America. Today, that cause is now being taken up by a new generation of leaders from both the left and right. These include Leonard Leo of the Federalist Society, Stephen Brogan, Steve Hilton, Frank Hanna III. Tom Monaghan and Vincenzo La Ruffa.

There are just as many liberal activist philanthropists, like Melinda Gates, as there are socially conservative non-profits, such as the Chiaroscuro Foundation, named after a Renaissance painting style that uses contrast for effect. "Reflecting God's light in a dark world" is the foundation's mission statement. Which sounds like a good place to start our survey – whatever your politics. CH

Robert Agostinelli

Chairman, Rhône Group

Rochester, NY native Robert Agostinelli, aged 69, attended the Aguinas Institute and served as an altar boy at Sacred Heart Cathedral with Bishop Fulton J Sheen. He earned his MBA at Columbia University. Joining Goldman Sachs in 1982, he left for Lazard's in 1987. Agostinelli struck out on his own in 1995 with the founding of New York-based private equity shop Rhône Group. He is active in philanthropic activities, including being a former chairman of the National Review Institute who set up the William F Buckley prize for leadership in political thought and as a member of the Reagan Ranch board of governors. In a caustic and widely applauded 2021 article in the National Review, Agostinelli spoke out about the crisis of Catholic identity on American campuses today after a return visit to Aguinas where he found the school indoctrinated with woke values that represented a form of "papier-mâché Catholicism". He lamented how far removed the school was from the Judeo-Christian values that had provided him with a "moral compass" for life.

Laure C Aubuchon **Commercial real estate**

a programme of Catholic Charities, where she is also on the advisory board. She was a trustee of Assumption College for 21 years. She is on the board of the WE Aubuchon Co, Inc, a family-owned business started by her grandfather in 1908. John and Daria Barry Foundation

John Barry is the chairman and chief executive officer of Prospect Capital Corporation and Prospect Capital Management (PCM). He is chairman of PCM's Investment Committee and has been an officer of PCM since 1990. Daria Barry is head of administration and managing director at Prospect Capital Management. She joined PCM in 1998 and oversees PCM's operations. They are philanthropists who run the John and Daria Barry Foundation which is committed to improving opportunities, with a focus on veterans, education and the environment.

Edward Bastian

CEO, Delta Air Lines

Edward Bastian, 65, has been CEO of Delta Air Lines since 2016. He received a bachelor of business administration in accounting from St Bonaventure University in New York. He recently met with Pope Francis at the Vatican, presenting the pontiff with a Roman cross, cut from a Delta engine blade, and a generous six-digit financial gift to a papal charity.

Patrick Baugier de Chevestre Wine distributor

Patrick Baugier de Chevestre is chairman and founder of Metrowine Distribution, one of the largest Bordeaux wine distributors in the US. He has a deep background in wine having grown up in Bordeaux, where his family has been active in the wine business for four centuries. He is a member of the Chevaliers du Tastevin, Commandeur of La Commanderie du Bontemps, and also belongs to the Jurade de Saint Emilion and L'Union Club Bordelais. Patrick holds a degree in law from the University of Assas in Paris.

Kim Bepler **Philanthropist**

Kim Bepler is the widow of Stephen E Bepler, and since his death in 2016 she has run the extensive Bepler family estate. Three new chairs were created at Fordham University thanks to a \$10.5 million legacy from her husband, and Bepler is now an honorary trustee fellow there. \$2.5 million will be added to the gift to a fund for a new science building planned for the Rose Hill campus, a project to which the Beplers have contributed \$7.8 million. Bepler has also started a fund for Fordham students affected by the crisis in Ukraine.

Frank Bisignano President and CEO, Fiserv

Frank J Bisignano, 63, is president and CEO of Fiserv. He has previously served as the CEO of First Data Corporation and the COO of JPMorgan Chase. In 2021, he was awarded with the Deus Caritas Est award by Cardinal Dolan for his work in assisting the poor via Catholic charities and other archdiocesan projects in New York. Among his non-profit commitments. Bisignano serves as a trustee of the Cathedral of St Patrick.

Robert E Campbell

Former VP. Johnson & Johnson

Robert E Campbell is a retired vice-chairman of the board of directors of Johnson & Johnson. He served as an Air Force officer for three years and during his J&J career held numerous positions in financial and general management. Campbell is trustee emeritus and past chairman of the board of trustees of Fordham University. After retiring in 1995, Campbell served as chairman of the Robert Wood Johnson Foundation, whose mission is to improve the health and healthcare of every American, and the Cancer Institute of New Jersev.

Joseph A Cari

Entrepreneur and philanthropist

Joseph A Cari Jr, from New York, is a banker, public policy expert. and philanthropist. Beyond this, his professional career has also included experience in the worlds of media, politics, law and education.

Cari was appointed by President Bill Clinton as chairman of the board of the Woodrow Wilson Center for International Scholars. a US government think-tank. He











has also established the Rita Bahr Cari Memorial Fund, named after his wife, at the University of Notre Dame. This aims to help in aiding those who suffer from humanrights violations.

Emanuel Chirico

Former chairman and director, PVH Corp

Emanuel Chirico is chairman of PVH Corp. It owns an iconic family of brands including Calvin Klein, Tommy Hilfiger and Van Heusen. Chirico has been with PVH for over 26 years, serving as CEO from 2006 to 2021 and as chairman since 2007.

Under his leadership PVH has become one of the largest and most admired fashion and lifestyle companies in the world, reaching \$9.9 billion in annual revenues in 2019 and 40,000 associates operating in over 40 countries. His philanthropic work includes serving on the board of trustees of his alma mater, Fordham University, as well as the board for Save the Children and the Healthcare Chaplaincy.

Jim Clerkin

CEO, Demeter & Co

Jim Clerkin has over 35 years of experience in the wine and spirits industry. He began his career in Ireland where he rose through the ranks at Guinness to become an executive member of the board of directors. In 2010, Clerkin was appointed to the position of CEO and president of Moët Hennessy USA, the leading luxury wines, spirits and champagne company in the world. Outside of work, he is the chairman of Co-Operation Ireland in the US, which is a notfor-profit organisation promoting peace and reconciliation.

Founder, PivotNorth Capital and philanthropists

Timothy Connors is the founder of PivotNorth Capital and a 25-year veteran of Silicon Valley, having co-founded five companies. He has built an extensive career in engineering and technology and as a venture capitalist. The focus of Wendy and Tim Connors's philanthropy is directed towards Catholic causes such as the University of Notre Dame, Catholic Charities San Francisco, the Sovereign Military Order of Malta, Saint Raymond Parish, and Sacred Heart Prep High School. They have also co-founded and funded OneParish.com. a free app and web platform designed to help parishes grow their community and increase members' involvement and giving.

Neil & Anne Corkery

Wellspring Committee

Neil and Anne Corkery are founders of the Wellspring Committee, an organisation operating out of Manassas, Virginia, which serves as a fund for conservative political non-profit groups. Founded in 2008, the Wellspring Committee regularly contributes funding to non-profits that create advertisements for Republican candidates and causes. Influential as a wellconnected power couple in Washington, they have supported Catholic appointments to the Supreme Court, and have supported groups that campaign against same-sex marriage and abortion.

John F Crowley **CEO**, Amicus Therapeutics

John F Crowley, 55, is the executive chairman of Amicus Therapeutics, a global biotechnology company which

Sean Fieler President and CIO, Equinox Partners

Sean Fieler is a charismatic figure in the New York financial and philanthropy world and named his Chiaroscuro Foundation after a painting style used by such Renaissance artists as Caravaggio,



which uses high contrast for maximum effect. "Reflecting God's light in a dark world" is how Fieler has described his foundation's socially conservative mission.

Upon completing undergraduate studies, Fieler joined Equinox Partners (a global value fund focused on emerging markets and gold mining) as an intern. He is now the firm's chief investment officer and majority owner. Fieler speaks and talks on the monetary system; he has lectured on monetary policy at the annual Grant's Conference, the Atlas Liberty Forum and has written for the *Wall Street Journal* and the *Hill*.

Fieler's Chiaroscuro Foundation invests in education, family strengthening, humanitarian work, pro-life activities, religious liberty, evangelism and other causes. A particular concern of Fieler's is the importance of family and marriage to American society. He has spoken out on the importance of upholding the traditional Catholic view of marriage and family values. He is focused on what can be achieved legally and politically to reduce the high incidence of abortion; his priority is preconception causes as much as post.

He first got into public-space philanthropy through attending a conference on family law at David Blankenhorn's Institute for American Values. "I got a sense of how deep the problems were surrounding families in America, both in our culture and in law and policy. I ended up joining the board," he told Philanthropy Roundtable. He admires Catholics like Clarence Thomas who are not afraid to speak out on moral issues, rather than trimming one's sails for expediency's sake.

Fieler once argued in the *New York Times* that it was disingenuous to argue that gay relationships "lend themselves to monogamy, stability, health and parenting in the same way heterosexual relationships do". As a result of his public stance, which includes opposition to transgender bathrooms (which he tried to abolish in California via the Privacy for All Act), Fieler has become a hero of the American cultural right. He is unabashed about describing himself as a social conservative fighting for religious liberty. "You can have freedom within your place of worship, but no rights to bring religious principles outside, into your life, your business, the public square," he has said.

He serves as chairman of the American Principles Project, Communio and the Knights of Columbus Charitable Fund. He lives in Stamford, Connecticut, with his wife Ana and six children. He and Ana were married in New York by Father John McGuire of the Dominicans. he founded in 2005 and which now has a presence in more than two dozen countries and a market value in excess of \$3 billion. Crowley's involvement with biotechnology stems from the 1998 diagnosis of two of his children with Pompe disease. In his drive to find a cure for them. he became an entrepreneur in the field. He is a former national chairman of the Make-A-Wish Foundation of America, and was awarded an honorary Doctor of Laws degree from the University of Notre Dame when he delivered the commencement address to the Class of 2020. He lives in Florida.

Daniel A D'Aniello

Co-founder, The Carlyle Group

Daniel A D'Aniello, 75, is a co-Founder and chairman of the Carlyle Group, a global alternative asset management company headquartered in Washington DC with over \$188 billion in assets under management. Prior to forming Carlyle in 1987, D'Aniello was a vice-president for Finance and Development at Marriott Corporation, and prior to that was a financial officer at Pepsi and Trans World Airlines. He is a 1974 graduate of the Harvard Business School, where he was a Teagle Foundation Fellow. In 2003, he and some Catholic business leaders founded the Lumen Institute, whose purpose is "to form business leaders and transform culture".

James M Davis

Founder, Packaging Express

James "Jim" Davis is founder and partner of Packaging Express of Colorado Springs. Previously, Davis was a partner in Denver's Deline Box Company for more than 30 years. In recognition of his professional success, he was inducted into the Association of Independent Corrugated Converters/Paperboard Packaging hall of fame in 2013. Outside work, his leadership carries over into his community service; he is a member of the National Advisory Board of the Catholic Leadership Institute.

Samuel A DiPiazza Chairman, Warner Bros

Samuel A DiPiazza Jr, 72, is the chairman of Warner Bros Discovery and is a former CEO of PricewaterhouseCoopers. He graduated from the University of Alabama with a bachelor's degree in accounting and earned a master of accountancy degree from the University of Houston. He joined PwC in 1973 and became a partner in 1979: the youngest in the firm's history. He is on the board of directors of St Patrick's Cathedral in New York City, Seton Education Partners, Inner City Scholarship of NY, and is a former member of the board of the National September 11 Memorial and Museum.

Charles Dolan

Founder, Cablevision and HBO

Charles Dolan is the founder of Cablevision and HBO. He served in the US Air Force at the end of World War II, after which he entered the field of telecommunications. The Fairfield University Dolan School of Business is named in recognition of his \$25 million donation and his service to the university as a member of the board of trustees. The Dolan Center for Science and Technology, completed in 2003 at a cost of over \$66 million, is John Carroll's showcase building. He is the chairman emeritus of the Lustgarten Foundation, the largest private funder of pancreatic cancer research in the world.

Dixon R Doll

Co-Founder & Partner Emeritus, DCM Ventures

For more than 35 years, Dixon

Doll has guided entrepreneurs, investors and executives in the computer, communications, and internet industries. Doll founded DCM Ventures, where he built a leading global VC firm with offices in Silicon Valley, Beijing and Tokyo. DCM is also widely regarded as the first Silicon Valley venture firm successfully to invest in China, Japan and the US. In 2021, Doll received the lifetime achievement award in venture capital from the US National Venture Capital Association. He sits on the boards of the Papal Foundation and the Catholic Investment Services.

The Fanjul Brothers Sugar magnates

Alfonso, José, Alexander and Andres Fanjul are all co-owners of Fanjul Corp. Comprising numerous subsidiaries, it is a huge sugar and real-estate conglomerate in the United States and the Dominican Republic. Some of its subsidiaries include La Romana International Airport, and many resorts surrounding La Romana in the Dominican Republic. All are Catholics; Pepe and Alfonso have been honoured by the Diocese of Palm Beach for their dedication to Catholic charities in the area.

Melinda French Gates

Philanthropist and former GM, Microsoft

Melinda French Gates, 58, is a philanthropist and former general manager at Microsoft. In 2000, she and her former husband Bill Gates founded the Bill & Melinda Gates Foundation. She has been awarded both the Presidential Medal of Freedom and the French Legion of Honour. Gates attended St Monica Catholic School and in 1982 graduated as valedictorian from the Ursuline Academy of Dallas. of Catholicism, however, and in 2012 she broke publicly with the Church's opposition to artificial birth control when the Gates Foundation launched a global campaign to expand reproductive rights for women.

David Hayes

Managing partner, MM Hayes Company

David Hayes is a managing partner at MM Hayes Co, a software company focused on labour-management solutions for the workplace and headquartered in Albany, New York. Hayes and his wife Lauren have been married for 26 years and have five children; the Hayes family's Irish heritage and Catholic faith have been integral parts of their lives, forming a foundation for success in business, sports, and most importantly family. He joined MM Hayes in 1988 after graduating from Boston College. He is presently one of the managing partners alongside his father Michael M Hayes and two brothers, Michael and John.

Thomas J Healey

Healey Family Foundation

Thomas J Healey, 79, was a partner at Goldman Sachs and is senior fellow at Harvard University's John F Kennedy School of Government. He was a former assistant secretary of the United States Treasury under President Ronald Reagan. He was a trustee and chairman of the Rockefeller Foundation Investment Committee and served a similar role at Georgetown University. He serves on the emeritus board of FADICA and received their 2020














Frank J Hanna III Entrepreneur and philanthropist

Frank J Hanna III is a leading Catholic philanthropist and entrepreneur who has been CEO of Hanna Capital in Atlanta, Georgia, since 2006. His influence is wide-ranging



and he is regarded by other Catholic philanthropists as a *primus inter pares* role model. Hanna has served on the boards of Catholic cable television network EWTN, the Catholic Leadership Institute and the Busch School of Business of the Catholic University of America. He also supports FOCUS (the Fellowship of Catholic University Students), Lumen Institute, the Pontifical North American College, and Sophia Institute Press.

Hanna was profiled in the PBS documentary *The Call of the Entrepreneur*. The son of "Pop", Hanna Jr was brought up seeing his father support many Atlanta charities and civic organisations as well as Atlanta's Holy Spirit parish in Buckhead, run by the charismatic Monsignor Edward Dillon.

Hanna has helped to shape Catholic life and education in America in a national role. He served as chair of a Commission on Education Excellence under President George W Bush, and he has been involved in 13 new educational institutions, from pre-school through post-secondary. These include two schools in Atlanta, serving on the boards of each: Holy Spirit Preparatory School and Holy Spirit College.

Hanna was chosen by George W Bush to be co-chair of the and religious liberty, and supports the Federalist Society, the Becket Fund for Religious Liberty, and the Acton Institute. He also supports, or serves on the board of, the American Enterprise Institute, the Ethics and Public Policy Center, the Institute for Marriage and Public Policy, and the Philanthropy Roundtable. He has written two books: What Your Money Means, and A Graduate's Guide to Life, the latter of which was recommended by George Weigel in *First Things*. As the attention in 2007 after it purchased the Mater Verbi (Hanna) Papyrus from the Bodmer Foundation in Cologny, and donated it to the Vatican Apostolic Library in a ceremony attended by Pope Benedict XVI. Dating from between AD 175 and 225, the papyrus is the oldest extant copy of portions of the Gospels of for philanthropic leadership, and the David R Jones award for philanthropic leadership. John Malone

Businessman, landowner and philanthropist

John Malone is a businessman and philanthropist who is also America's largest private landowner. Born in Connecticut, he built Tele-Communications Inc into a cable and media giant from 1973 to 1996. Malone is now chairman and largest voting shareholder of Liberty Media, which owns F1, Liberty Global and Qurate Retail Group. He also owns 7 per cent of Lionsgate and Starz Inc.

A leading philanthropist, his causes are focused on land preservation, medical research and animal rescue. "You should use your money to do what you regard as good things for your society and your fellow men," he has said. "I also don't believe in hereditary wealth." His gifts include Yale's Daniel L Malone Engineering Center, named after Malone's father. He has gifted \$50m to the university's engineering school and another \$30m to the Johns Hopkins Whiting School of Engineering to build the Malone Hall. He owns several million acres including estates in New Mexico, Florida, Maryland, Maine New Hampshire, Colorado and Wyoming. He is proud of his Irish heritage and is a self-confessed "restore-a-wreck" historic-property buyer. He has restored Humewood Castle in Wicklow, various hotels in Dublin and Limerick and Castlemartin House on the banks of the Liffey, in County Kildare. The former home of media tycoon Tony O'Reilly, the estate includes a restored medieval church, St Mary's, which was reconsecrated for Catholic worship in 1981.

Patrick W McGrory

Chairman, the Raskob Foundation for Catholic Activities

Patrick W McGrory is a privatewealth specialist with Liberty Point Advisors. He has played a significant role for over 25 years in his family's foundation, the Raskob Foundation for Catholic Activities, which supports domestic and international projects from institutions and organisations identified with the Catholic Church; he serves as the chairman. He is also actively involved in politics and endorsed Donald Trump in 2020.

Christine Schwarzman is the lawyer wife of Stephen Schwarzman, the founder and CEO of Blackstone, Christine, a Roman Catholic, married Schwarzmann (who is Jewish) in 1995 in an interfaith ceremony. In 2001, she introduced him to the late Archbishop of New York, Cardinal Edward Egan, and Schwarzman reportedly gave Egan financial advice to help the finances of the archdiocese. The Schwarzmans have been sponsoring students at Catholic schools for many years. In 2015, they donated \$40 million to help underprivileged students receive a Catholic education, and then welcomed Pope Francis to Our Lady Queen of Angels School in East Harlem, New York.

MacKenzie Scott, 52, is a novelist and philanthropist who is the ex-wife of the former Amazon founder Jeff Bezos. At Princeton, she was taught by Toni Morrison, the Nobel Prize-winning Catholic novelist. Morrison introduced her to Jeff Bezos. Named as one of Time's 100 most influential people of 2020, she has signed the Giving Pledge. In 2021, she gave several million dollars to a multireligious advocacy group, Faith in Public Life. The group, according to CNA, takes a "progressive" view in regards to the Catholic bishops' debate on the Eucharist and Catholic public figures.

Samuel Alito Associate justice, US Supreme Court

Samuel Alito, 72, is an American lawyer, devout Catholic and jurist who serves as an associate justice of the Supreme Court of the United States. He was nominated by President George W Bush in 2005, and has served since 31 January, 2006. He is the 11th Roman Catholic and also, after Antonin Scalia, the second Italian-American justice to serve on the US Supreme Court. Alito wrote the Supreme Court's decision overturning Roe v Wade and delivered a speech to the Religious Liberty Conference on 21 July saying that religious freedom was "under attack in many places because it is dangerous to those who want to hold complete power".

Carl A Anderson

Lawyer and former supreme knight of Columbus

Carl Anderson, 71, is a lawyer who, until 2021, served as the 13th supreme knight of the Knights of Columbus. He is a board member of the Basilica of the National Shrine of the Immaculate Conception and has served as a member of the board of trustees of the Catholic University of America and the National Catholic Educational Association. Anderson is also vice president of the Washington session of the Pontifical John Paul II Institute for Studies on Marriage and Family.

Amy Coney Barrett Associate justice,

US Supreme Court

Amy Coney Barrett, 50, is an associate justice of the Supreme Court of the United States. She is the fifth woman to serve on the court after receiving the nomination from former president Donald Trump in 2020. Before and while serving on the federal bench, she has been a professor of law at Notre Dame Law School. In June 2022, Barrett voted to completely overturn Roe v Wade and Planned Parenthood v Casey. In June 2021, Barrett joined a unanimous decision in Fulton v City of Philadelphia, ruling in favour of a Catholic social service agency denied funding from the City of Philadelphia because it does not adopt to same-sex couples.

Noel Francisco

Former US Solicitor General

Noel Francisco, 53, is a senior Jones Day lawyer in DC who served as 47th Solicitor General of the USA under Donald Trump from 2017-20. He is the first Asian-American to hold the position. His Philippine father immigrated to America to become a doctor in New York. He is married with two daughters, lives in Washington, and has served on the board of the Lumen Christi Institute.

Peter J Johnson Jr President.

Leahey & Johnson

Peter James Johnson Jr is president of Leahey & Johnson in New York, where he has earned a reputation for excellence as a

Stephen Brogan Managing partner, Jones Day

Steve Brogan, a law graduate of Notre Dame and Boston College, is one of the most influential and respected Catholics in Washington. As managing partner of Jones Day, he has overseen the firm for 20 years with

a CEO-like role over the firm's 40-plus global offices (he closed its Moscow doors in 2019). The *New York Times* has described the firm as a "global Goliath... bringing all the ruthless energy and creativity of corporate law to the political realm". With 13 of his firm's lawyers forming part of the Trump administration, including former White House counsel Don McGahn, the firm under Brogan has exercised unrivalled access and power in Washington. The firm has also played an influential role in filling US courts with conservative Federalist Society judges.

The son of a New York police officer, Brogan's faith is a key to what drives him. He is a "hardcore Catholic and that is the bedrock of who he is", a Jones Day source told the *New York Times* in a 2022 profile of the firm. Under Brogan, Jones Day has also shown strong moral leadership in terms of taking on ideological appeal cases and helping the needy and vulnerable in a wide range of international and domestic causes including Ukraine, human trafficking, the rule of law in Africa and border immigration.

Just days after Russia invaded Ukraine, Brogan established a Ukraine task force of lawyers across the US, Europe and the Middle East. This has made charitable contributions and legal assistance to refugees, taken in Ukrainian law students and supported efforts to rebuild the country.

Brogan notably represented the Roman Catholic Church in its litigation battle against President Obama's health insurance law. This ruled that employers had to cover the cost of contraception. In June 2017, the Justice Departmemt overruled this, with Jones Day donating its services to the Catholic groups it represented who filed lawsuits. He is one of America's leading corporate lawyers dealing in complex litigation matters. Now aged around 70, he is reported to be handpicking his successor just as Patrick McCartan, his predecessor, did in appointing 50-year-old Brogan in 2002. Both lawyers share close ties to the University of Notre Dame: Brogan serves on its board of trustees, which McCartan once chaired.

He has served as national outreach for the Republican National Committee, and as the 2004 Bush presidential campaign's Catholic strategist. He was appointed by President George W Bush and the United State Senate to three terms on the United States Commission on International Religious Freedom.

Leo is a board member of the National Catholic Prayer Breakfast and he has served three terms on the United States Commission on International Religious Freedom. He is also a Knight of Malta. He is known for wearing tailored suits and for carrying a pocket watch.

Brett Kavanaugh

Associate justice, US Supreme Court

Brett Kavanaugh, 57, is an associate justice of the Supreme Court of the United States. He was nominated by former president Donald Trump in 2018 and was confirmed on a closely contested vote in the US Senate. He was previously a US circuit judge of the US Court of Appeals for the District of Columbia Circuit. He is of Irish Catholic descent on both sides of his family. He has helped serve meals to the homeless as part of church programmes and has tutored at the Washington Jesuit Academy, a Catholic private school in the District of Columbia.

Raymond Kelly

Former commissioner, New York City Police

Raymond Kelly, 81, is a former New York police commissioner. He is the longest-serving commissioner in the history of the NYPD and the first man to hold the post for two non-consecutive tenures. Kelly had spent 45 years in the NYPD, serving in 25 different commands. He was a Marine Corps Reserve colonel, director of police under the United Nations Mission in Haiti, and an Interpol vice president. Kelly graduated from Archbishop Mollov High School in 1959 and also holds a JD from the St John's University School of Law.

Charles LiMandri Lawyer

Charles LiMandri, 66, is an American lawyer based in California. He famously litigated against the American Civil Liberties Union in the defence of the Mount Soledad Cross in San Diego. The case lasted 25 years. In 2002, he founded the Freedom of Conscience Defense Fund (FCDF) to aid in paying for his pro bono work on behalf of religious freedom. In 2021 he successfully litigated against the State of California before the United States Supreme Court to force the governor to open the churches for 40 million people. In 2022 he merged the FCDF into the Thomas More Society, a national Catholic public interest law firm that promotes and protects traditional family and pro-life values and the religious freedom of Christians, through litigation and educational programmes.

George D Molinsky Partner, Taft Law

George D Molinsky is a partner at Taft Law in Cincinnati, where he specialises in corporate law. He is recognised by Best Lawyers in America for his work in corporate law and has been named lawyer of the year multiple times for his practice. Molinsky is a board member for Ruah Woods. Cincinnati Zoo and Botanical Gardens, The Brandery and the Greater Cincinnati Chamber of Commerce Government Affairs Committee. He attended the University of Notre Dame where he received his BA and his JD.

Thomas Moore

Senior partner, Kramer, Dillof, Livingston & Moore

Thomas Moore is a senior partner at the New York law firm Kramer, Dillof, Livingston & Moore. He is recognised as one of the best trial lawyers in the US and is known for winning nine out of ten cases. Moore has been named lawyer of the year multiple times by Super Lawyers magazine. In addition, he is a member of the Inner Circle of Advocates, an elite group of the top 100 trial attorneys in the country. Moore attended the Catholic University of America and Fordham Law School. He has funded scholarships for Fordham and endowed a chair in trial advocacy.

John Roberts 17th chief justice,

US Supreme Court

John Roberts, 67, has served as the 17th chief justice of the United States Supreme Court since his appointment by President George W Bush in 2005. Roberts one of 15 Catholic judges in the Supreme Court's history and one of six Catholic justices on the current Supreme Court. Yet despite his Catholic faith and image as a conservative justice, Roberts has often compromised with the court's liberals on social issues. He has voted in favour of certain restrictions to abortion, but he was not in favour of overtturning Roe v Wade.

Joseph E Schmitz

Former executive, Blackwater Worldwide

Joseph E Schmitz, 66, is a lawyer, former executive at Blackwater Worldwide and also a former inspector general of the United States Department of Defence. In addition, Schmitz served in the US Navy for four years, was an adjunct professor of law at Georgetown University, and founded his own firm, Joseph Schmitz PLLC. Schmitz is also a member of the Sovereign Military Order of Malta.

Nina Shea

Human rights lawyer

Nina Shea, 69, is an international human rights lawyer and Christian religious freedom advocate. She is the former director for the Center of Religious Freedom at Freedom House. Since 2006, Shea has held the position of senior fellow at the Hudson Institute and directs the Institute's Center for Religious Freedom. In 2009, she was appointed commissioner on the US National Commission to UNESCO. She was also the US delegate to the United Nations Human Rights Council. She has authored two books on anti-Christian discrimination: *In the Lion's Den* and *Silenced*.

Sonia Sotomayor

Associate justice, US Supreme Court

Sonia Sotomayor, 68, has served on the United States Supreme Court since her appointment by President Barack Obama in 2009. She is the third woman and the first Hispanic to serve on America's highest court. Prior to her appointment, Sotomayor served on the US District Court for the Southern District of New York and on the US Appeals Court for the Second Circuit. Although raised in the Catholic faith, Sotomayor has constantly challenged Church teaching throughout her judicial career and has constantly ruled in favour of abortion and samesex marriage.

Clarence Thomas

Associate justice, US Supreme Court

Clarence Thomas, 74, has served as a justice on the United States Supreme Court since his appointment by President George HW Bush in 1991. He is often described as the Supreme Court's most conservative justice.

After falling away from his faith, he was reconciled with the Catholic Church in the mid-1990s. During his tenure as a Supreme Court justice, he has constantly defended Church teaching on marriage and family. He wrote a dissenting opinion in the 2015 Obergefell v Hodges case which legalised same-sex marriage, and he wrote a concurring opinion in the 2022 Dobbs v Jackson case which overturned Roe v Wade.

William Barr

Former US attorney general

William Barr is an attorney who served as United States attorney general in the administrations of Presidents George Bush and Donald Trump. In the late 1990s he was a "Supreme Board Member" of the Knights of Columbus, but today he is just a member. For 21 years, Barr was also on the board of the DC-based Becket Fund for Religious Liberty.

Joe and Jill Biden

President and First Lady of the United States

Joseph Biden, 79, is the 46th president of the United States and the second Catholic president, after John F Kennedy, and also a Democrat of Irish heritage. He served as the 47th vice president from 2009 to 2017. In 2016, Biden was awarded the Laetare Medal, considered the highest honour for American Catholics, by the University of Notre Dame. Jill Biden, 71, is an American educator and the first lady of the United States. They both often make donations to Catholic charities and attend Mass but have been consistently criticised by members of the clergy – and Catholic lay leaders – for a voting and political record that does not reflect Catholic values, such as their stance on abortion.

Biden's election campaign was heavily supported by Planned Parenthood and he has called on Americans to make the overturning of Roe v Wade a political issue. In a 2021 cover story for the *Catholic Herald*, NYC priest Gerald Murray said that he would not give the president holy communion.

Biden had a 90-minute audience with the Holy Father at the Vatican in October 2021. He also has a photo of Pope Francis in the White House Oval Office.

John Boehner

Former speaker, US House of Representatives

John Boehner, 72, is a Catholic who grew up as one of 12 children. He is a former politician who served as the 53rd speaker of the United States House of Representatives from 2011 to 2015. A Republican, he was the representative for Ohio's 8th congressional district from 1991 to 2015. In 2016, Boehner was awarded the Laetare Medal by the University of Notre Dame.

Jeb Bush

Former governor of Florida

John "Jeb" Bush, 69 and from Houston, is a former politician and businessman who has previously served as the 43rd governor of Florida. He is the son of former president George HW Bush and former first lady Barbara Bush, and a younger brother of former president George W Bush. In 1995, Bush converted to Roman Catholicism and is now a fourthdegree Knight of Columbus.

Henry Cuellar

US representative for Texas

Henry Cuellar, 66, is an attorney and politician who has served as the US representative for Texas's 28th congressional district since 2005. He is widely considered to be one of the most conservative members of the Democratic Party. Cuellar has said that his Catholic faith has guided him throughout his political career.

Andrew Cuomo

Former New York mayor

Andrew Cuomo, 64, is an American lawyer and politician who served as the 56th governor of New York from 2011 to 2021. At the time of his resignation, he was the longest-serving governor in the United States still in position. Born 56 US CATHOLIC LEADERS

in Queens, New York City, Cuomo is a graduate of Fordham University and Albany Law School. He is a Roman Catholic but has positioned himself in favour of abortion rights and same-sex marriage. His father Mario, also once mayor of New York, was a devout and publicly self-proclaimed Catholic, as is Andrew's brother Chris.

Marjorie Dannenfelser

President, Susan B Anthony Pro-Life America

Marjorie Dannenfelser, 56, is the president of Susan B Anthony Pro-Life America, a non-profit organisation that seeks to reduce and ultimately end abortion in the US by supporting anti-abortion politicians, primarily women. She was brought into the organisation as its executive director in 1993. Although she grew up as an Episcopalian, she converted to Catholicism and adopted an antiabortion stance while attending Duke University.

Ron DeSantis

Governor of Florida

Ronald DeSantis, 44, is a practising Catholic and an attorney and politician who has served as the 46th governor of Florida since 2019. Before this, DeSantis represented Florida's 6th district in the US House of Representatives for five years. DeSantis joined the United States Navy in 2004 and was promoted to lieutenant before being deployed to Iraq in 2007. DeSantis attended Our Lady of Lourdes Catholic School and Dunedin High School, graduating in 1997.

Miguel H Díaz Former US ambassador to the Holy See

Miguel Díaz, 59, is a theologian and diplomat who served as United States ambassador to the Holy See from 2009 to 2012, following the nomination by President Barack Obama. He was the first Hispanic US ambassador accredited to the Holy See. Díaz holds the John Courtney Murray, SJ, University Chair in Public Service at Loyola University Chicago. He has authored several books and is the co-editor of Disruptive Cartographers: Doing Theology Latinamente. He is a contributor to the "Theology en la Plaza" column for the National Catholic Reporter. As part of his commitment to human rights, he participates in diplomatic initiatives in Washington DC, including being a member of the Atlantic Council, a member of the Ambassadors Circle at the National Democratic Institute, and a member of the board and senior fellow for Religion and Peacebuilding for the Alliance for Peacebuilding. Díaz holds a

the University of Notre Dame.

Joseph Donnelly, 66, is an American attorney, politician and diplomat who served as a US senator from Indiana from 2013 to 2019. Since 2022, he has served as the US ambassador to the Holy See. Born in Massapequa, New York, Donnelly graduated from the University of Notre Dame. Donnelly met his wife, Jill, while attending Notre Dame; the two married in 1979. They have two children.

Catherine Glenn Foster

President and CEO, Americans United for Life

Catherine Glenn Foster, JD, serves as president and CEO of Americans United for Life. Americans United for Life is US's original national prolife organisation, the nation's premier pro-life legal team whose strategists have been involved in every pro-life case before the US Supreme Court since Roe v Wade.

Kathy Hochul

Governor of New York

Kathleen Hochul, 64, is an American lawyer and politician who has served as the 57th governor of New York since 2021. A Democrat, she is New York's first female governor. Her family is of Irish Catholic descent. She received her BA in political science from the Maxwell School of Syracuse University in 1980 and a JD from the Catholic University Columbus School of Law in 1984. She is proudly pro-choice.

John Hoeven

Senator, North Dakota

John Hoeven, 65, is a banker and Republican politician who has served as the senior US senator from North Dakota since 2011 and as the 31st governor of North Dakota from 2000 to 2010. Before being elected governor, Hoeven was a banker who undertook numerous executive roles at various banks. He is on the board of directors at First Western Bank & Trust, and with an estimated net worth of \$45 million, he is one of the wealthiest US senators. As a Catholic, he takes both an antisame-sex marriage and pro-life stance and votes accordingly.

John Kerry

US special presidential envoy for climate

John Kerry, 78 and from Massachusetts, is an American attorney, politician and diplomat who is the first United States special presidential envoy for climate. A member of Boston's influential Forbes family and the Democratic Party, he served as the 68th US secretary of state from 2013-2017 under Barack Obama. Kerry came to public attention as a decorated naval officer and Vietnam veteran turned anti-war activist. He is said to have carried a religious rosary, a prayer book, and a St Christopher medal when he campaigned. At school he considered becoming a priest.

Alan Keyes

Political activist and former ambassador

Alan Keyes, 72, is an American conservative political activist, author and former ambassador. He has run for president of the United States three times and has served on the board of advisers for the Catholic League, a non-profit Catholic advocacy group headed by William Donohue. Keyes is a traditional Catholic and a thirddegree Knight of Columbus.

Wayne LaPierre

CEO and VP, the National Rifle Association of America

Wayne LaPierre, 72, is an American gun rights lobbyist who was raised in the Catholic Church. He is CEO and executive VP of the National Rifle Association of America, one of the most influential advocacy groups in the USA, a position he has held since 1991.

Leon Panetta

Former US Secretary of Defence

Leon Panetta, 84 and a resident of California, served as US Secretary of Defence under President Barack Obama from 2011-13. He previously served as director of the CIA and White House chief of staff. He oversaw the operation that brought down Osama bin Laden in 2011. Panetta also served as Director

of the Office of Management and Budget under President Bill Clinton, and as a representative from California. He currently serves as the chairman for the Panetta Institute of Public Policy. Panetta is the son of Italian immigrants and, growing up, attended two Catholic grammar schools.











Nancy Pelosi Speaker, US House of Representatives

Nancy Pelosi, 82, is the Speaker of the US House of Representatives, a position she previously also held from 2007-11. She is the first woman to hold the position. She previously served as a US Representative from California since 1987. Before her election to Congress. Pelosi chaired the California Democratic Party from 1983-87. Although she claims to be a devout Catholic and often speaks about her faith, she has spent much of her political life in opposition to Church teachings on abortion and same-sex marriage. In 2022, her archbishop Salvatore Cordileone barred her from receiving communion in his San Francisco diocese over her support for abortion, yet a month later she received holy communion at a papal Mass at the Vatican.

Mike Rounds

Junior US senator, South Dakota

Michael Rounds, 67, is an American businessman and politician serving as the junior US senator from South Dakota since 2015. In 2014, Rounds was elected to the United States Senate, succeeding retiring Democrat Tim Johnson. As a Catholic, Rounds promotes a pro-life view and is also a member of Ss Peter and Paul Catholic Church in Pierre, South Dakota.

Jim Risch

Junior US senator, Idaho

Jim Risch, 79, has served as the junior United States senator from Idaho since 2009. He previously served as lieutenant governor of Idaho from 2003-06 and 2007-09,

He has been a constant supporter of prolife legislation and co-sponsored the Child Interstate Abortion Notification Act, which would have made it illegal for a minor to cross state lines for an abortion.

Marco Rubio Senior US senator, Florida

Marco Rubio, 51, has served as the senior United States senator from Florida since 2011. He was Speaker of the House for the Florida House of Representatives from 2006 to 2008. In 2016, Rubio unsuccessfully ran for the Republican presidential nomination. He attends Mass at Church of the Little Flower in Coral Gables, Florida. His Catholic faith has influenced his political philosophy and congressional career. He is a staunch opponent of abortion and has said he disagrees with the 2015 Obergefell v Hodges Supreme Court decision which legalised same-sex marriage.

Paul Ryan

Former Speaker, US House of Representatives

Paul Ryan, 52, served as the Speaker of the United States House of Representatives from 2015-19. He was the vicepresidential nominee in the 2012 presidential election, running alongside Mitt Romney. Ryan is a Catholic and attends St John Vianney Church in Janesville, WI. His faith has informed his political career. He opposes abortion and same-sex marriage, yet he does favour same-sex civil unions.

Rick Santorum

Former US senator, Pennsylvania

Rick Santorum, 64, served as a United States senator from Pennsylvania from 1995 to 2007 and was the Senate's third-ranking Republican from 2001-07. He ran for the Republican presidential nomination in 2012, finishing second behind Mitt Romney, and ran again in 2016. Santorum calls himself a culture warrior and a true Christian conservative. He has supported pro-life legislation throughout his career, proposed a ban on pornography, and has opposed same-sex marriage.

Steve Scalise

US House of Representatives Minority Whip

Steve Scalise, 56, is the United States House of Representatives Minority Whip and representative for Louisiana's 1st congressional district. He comes from an Italian-Catholic background and his faith has been a driving factor in his political career. He staunchly opposes same-sex marriage. In 2017, Scalise was shot by a left-wing extremist during practice for the Republican team's annual congressional baseball game. Scalise survived the shooting and has written about how the incident strengthened his faith.

Dan Sullivan Senator, Alaska

Dan Sullivan, 57, has served as a Republican senator from Alaska since 2015. He previously served as Alaska's Attorney General. Senator Sullivan comes from a Catholic family and as such is generally pro-life, except in the cases of rape, incest or risk to -the mother, and he opposes same-sex marriage.

Pat Toomey

Senator, Pennsylvania

Pat Toomey, 60, has served as a Republican senator from Pennsylvania since 2011. He previously served as a member of the US House of Representatives from 1999 to 2005. In addition to his work in politics, Toomey has worked in the financial services industry, served as president of the Club for Growth and owned and operated a small restaurant chain in the Lehigh Valley in Pennsylvania. Toomey comes from a Catholic family, being the third of six children of Catholic parents of Irish and Portuguese descent. Toomey is staunchly pro-life, and has consistently supported measures to either restrict or ban abortion during his time in the Senate.

Melania Trump Former first lady

Melania Trump, 52, is a Slovenian- $\stackrel{\text{V}}{\leftarrow}$ born former model and businesswoman who was first lady of the United States under President Donald Trump, whom she married in 2005. Raised Catholic. Trump identifies as Catholic and was only the second Catholic first lady in the United States. In 2017, she visited the Vatican with the president on an official visit and met Pope Francis. During this visit, Pope Francis blessed her rosary beads, and she placed flowers at the feet of a statue of the Blessed Virgin Marv ੱ at the Vatican children's hospital.

Education

Mark Bradford

Executive director, Regina Academies

Mark Bradford, who lives in Pennsylvania, is the executive director of the Regina Academies, a network of Philadelphia-area schools offering Catholic classical education for students from prekindergarten to grade 12. Bradford worked for ten years at St Charles Borromeo Seminary and then served as headmaster of a parentfounded, Catholic K-12 classical academy in western Pennsylvania.

John J DeGioia President Georgetown University

John J DeGioia, 65, is an academic administrator,

philosopher and member of the Order of Malta. He has been the first lay president of Georgetown University in Washington DC since his appointment in 2001. He was also the first lay president of any Jesuit university in America. He is currently Georgetown's longestserving president. In 1994, he married his wife Theresa at Holy Trinity Church in a ceremony presided over by DeGioia's uncle, John Begley, a Jesuit priest. Though he may not identify as a public Catholic leader, DeGioia is a Catholic running an important liberal-leaning Catholic university.

Mary Ann Glendon Professor of law, Harvard Law School

Mary Ann Glendon is a highly influential Catholic thought leader who famously declined to receive Notre Dame's Laetare Medal on

account of the university inviting Barack Obama as key speaker and giving him an honorary degree. She argued that endorsing Obama was contradictory to the Conference of Catholic Bishops' 2004 decree that Catholic institutions should not give "awards, honours, or platforms" to "those who act in defiance of [Catholic] fundamental moral principles." She is the recipient of the National Humanities Medal and an expert on bioethics and human rights in international law. She is pro-life and a strong advocate of any legal expansion of abortion rights. She has taught at Boston College Law School and Harvard Law School. From 2008-09, she was US ambassador to the Holv See. In 2013, Pope Francis named Glendon a member of the Pontifical Commission of inquiry into the Vatican Bank. She resigned in 2018. She is on the board of directors for First Things. In 2018, she was finally honoured by Notre Dame's Center for Ethics and Culture with their Evangelium Vitae Medal. She has three daughters.

Peter Kilpatrick

President, Catholic University of America

Peter Kilpatrick, the 16th president of the Catholic University of America in Washington DC, is an experienced leader, educator and scholar, He is widely published and holds or shares 12 patents in chemical engineering. He began his career at North Carolina State University and, after 24 years, was recruited by the University of Notre Dame to be dean of engineering.

Since 2018, he has been the provost and vice president for academic affairs for the Illinois Institute of Technology, an institution dedicated to lifting up people of all backgrounds. Combining research and faith is important to Kilpatrick, who became Catholic as an adult.

Peter Kreeft

Professor of philosophy, Boston College

Peter John Kreeft, 85, is a professor of philosophy at Boston College and The King's College. A convert to Roman Catholicism, he is the author of over 80 books on Christian philosophy, theology and apologetics. He also formulated, together with Ronald K Tacelli, 20 arguments for the existence of God in their Handbook of Christian Apologetics.

Daniel Mahoney

Professor of politics, Assumption College

Daniel Mahoney, professor emeritus of politics at Assumption





College Massachusetts, has written widely on politics and political thought, statesmanship, and religion and public life. He is a senior fellow at the Claremont Institute on statesmanshin and political philosophy. In 1999, Mahoney was the recipient of the Prix Raymond Aron. He is the executive editor of Perspectives on Political Science and a senior writer at Law and Liberty. He is the author of several books and has written for Crisis, First Things, The New Criterion, and the Wall Street Journal. He is an authority on the French political philosopher Raymond Aron and the Russian novelist Aleksandr Solzhenitsyn.

John T McGreevy Provost,

University of Notre Dame

John McGreevy has been the Charles and Jill Fischer Provost of the University of Notre Dame (the second-highest rank) since July 2022. He was formerly the dean of the arts faculty from 2008 until 2018. A graduate of Notre Dame, McGreevy is an acclaimed historian, who is the Francis A McAnaney Professor of History at the university. He is married to Jean McManus, a librarian in Notre Dame's Hesburgh Libraries. He is the author of *Catholicism and American Freedom*.

Vincent Rougeau

President, College of the Holy Cross

Vincent Rougeau is a legal scholar who currently serves as president of the College of the Holy Cross in Massachusetts; he is the first lay and first Black president in the history of the university. Rougeau has written extensively on law and religions with a particular focus on Catholic social teaching and the law. His book *Christians in the American Empire: Faith and Citizenship in the New World Order* came out in 2008. He is a senior fellow at the Centre for Theology and Community in London.

Terrence M Sawyer President,

Loyola University Maryland

Terrence M Sawyer has served as the 25th president of Loyola University Maryland since the start of 2022. Prior to working at Loyola, Sawyer was an attorney for the Maryland Department of Business and Economic Development and practised civil and criminal law in Baltimore City. He is a member of the Maryland State Bar. Sawyer and his wife are devout Catholics and parishioners at the Church of the Nativity in Timonium, Maryland.

Julie Sullivan President.

Santa Clara University

Julie Sullivan is president of Santa Clara University in California. She is a leader in Catholic higher education and an internationallyrecognised scholar in economics. She joined Santa Clara in 2022, having previously served as president of the University of St Thomas where she created dynamic academic programmes and championed social innovation. She is the first lay and first woman president in Santa Clara University's history.

Tania Tetlow

President, Fordham University

Tania Tetlow is the 33rd president of Fordham University – the first layperson and woman to hold that office. She had been the 17th president of Loyola University New Orleans where she was the first woman and layperson to lead Loyola since the Society of Jesus founded it in 1912. A Catholic born in New York and raised in New Orleans, she has deep ties to the Jesuits and to Fordham.

Sohrab Ahmari

Columnist, editor and nonfiction author

Born in Tehran and based in New York, Sohrab Ahmari, 37, is co-founder of the online political magazine Compact, a former editorial writer for the Wall Street Journal, and former op-ed editor of the New York Post. He is an outspoken critic and has argued that politics and public discourse should be a forum of "war and enmity", with culturally conservative values being imposed on society. Ahmari is a contributing editor of the Catholic Herald which published the first account of his iournev from atheism to Roman Catholicism in 2016. He is the author of The New Philistines: How Identity Politics Disfigure the Arts, a spiritual memoir, From Fire, by Water and The Unbroken Thread: Discovering the Wisdom of Tradition in an Age of Chaos.

John L Allen Jr

Editor, Crux

John L Allen Jr, 57, is founder and editor of the Roman Catholic–

oriented news site Crux. Allen also serves as a senior Vatican analyst for CNN, and has featured in coverage of the conclaves of 2005 and 2013. He is the author of 12 books about the Catholic Church and has written two biographies of Pope Benedict XVI.

Raymond Arroyo

Author, broadcaster and EWTN host

Raymond Arroyo, 51 and a resident of New Orleans, is the news director and lead anchor of EWTN News, a division of the Eternal Word Television Network. He is also the creator and host of the programme *The World Over Live* and author of the Will Wilder series for young readers. Arroyo is a producer of the bestselling, all-star audio Bible, *The Word of Promise*.

Pete Bevacqua Chairman, NBC Sports Group

New York native Pete Bevacqua is a corporate, media and sports executive. Since 2020, he has served as chairman of NBC Sports Group. Bevacqua formerly held the US CATHOLIC LEADERS Media

She was also nominated for an Emmy award for her work on *America: A Tribute to Heroes*. She is a practising Roman Catholic and lives in New York City where she attends St Thomas More Church on Manhattan's Upper East Side.

Bill O'Reilly

Journalist and TV host

Bill O'Reilly, 73, is a political commentator, journalist and TV host. He hosts the podcast *No Spin News*. Prior to joining Fox he served as a reporter for several local news stations in the US as well as ABC News and CBS News. O'Reilly was raised in a Catholic family and attended Chaminade Catholic High School in Mineola, New York. He and his wife were married at St Brigid Parish in Westbury, New York.

Rusty Reno Editor, First Things

Russell Ronald Reno III, 63, is the editor of *First Things* magazine. He was formerly a professor of theology and ethics at Creighton University. A theological and political conservative, Reno was not originally Catholic, having been baptised into the Episcopal Church and growing up as a member of the Church of the Redeemer in Baltimore. However in 2004 he was received into the Catholic Church.

Robert Royal

Author and president, Faith & Reason Institute

Robert Royal is an influential broadcaster and conservative commentator who is president of the Faith & Reason Institute based in Washington DC. A former Fulbright Scholar, he is editor-in-chief of the The Catholic Thing site which he founded with Michael Novak. He is also the St John Henry Newman Visiting Chair in Catholic Studies at Thomas More College of Liberal Arts in Merrimack, NH.

Eric Sammons

Editor-in-chief. Crisis Magazine

Eric Sammons is the executive director of Crisis Publications and the editor-in-chief of *Crisis Magazine*. He is the author of several books including *Deadly Indifference*, *The Old Evangelization* and *Holiness for Everyone*. He has contributed several essays and articles to publications such as *OnePeterFive*, *The Federalist*, and CatholicVote. He is a board member of the Confraternity of Our Lady of Fatima. He considers himself a "traditional Catholic".

Maria Shriver

Journalist and author

Maria Shriver, 66, is a former First Lady of California, and the founder of the Women's Alzheimer's Movement. She was married to former governor of California and actor Arnold Schwarzenegger, whom she divorced in 2021. Shriver earned two Emmys for her role in developing *The Alzheimer's Project*, called a "television show with a conscience". She is a practising Catholic.

Andrew Sullivan Journalist

Washington DC resident Andrew Sullivan, 59, is a British-American author, editor and blogger. Sullivan is a political commentator, a former editor of the *New Republic* and the author or editor of six books. He started a political blog, the Daily Dish, in 2000 and eventually moved to platforms including *Time*, *The Atlantic* and *The Daily Beast*, and finally to an independent subscription-based format. From 2016 to 2020, Sullivan was a writer-at-large at *New York* and his newsletter, the "Weekly Dish", was launched in July 2020. Sullivan is a Catholic and has attributed his notorious conservatism to this background.

Brandon Vogt

Founder, ClaritasU and senior publishing director, Word on Fire Ministries

Brandon Vogt, from Orlando, founded ClaritasU and is the senior publishing director for Bishop Robert Barron's Word on Fire Catholic Ministries. He is also the founder of Chesterton Academy of Orlando, a classical high school rooted in the Catholic faith. He has served as a consultant for the US Conference of Catholic Bishops' Committee on Evangelisation and Catechesis and on the board of the Society of GK Chesterton. He has authored 11 books including Why I am Catholic (And You Should Be Too) and Return: How to Draw Your Child Back to the Faith. He has been featured on news outlets and publications including Fox News, CBS, EWTN, NPR and National Review.

Michael Warsaw Chairman and CEO, EWTN

Michael P Warsaw is the chairman and CEO of EWTN and publisher of the National Catholic Register. He joined EWTN in 1991, became president in 2000 and assumed the role of CEO in 2009. Professor and author

Patrick Deneen, 58, is professor of political science at the University of Notre Dame, where he has taught since 2012. Previously he taught at Princeton University (1997-2005) and Georgetown University (2005-2012), where he held the Eleni and Markos Tsakopoulos Kounalakis Chair in Hellenic Studies. He is the author of numerous essays and several books including *Why Liberalism Failed* (Yale, 2018), which has been translated into 14 languages.

Mary Eberstadt

Essayist, novelist and public speaker

Mary Eberstadt, 61, holds the Panula Chair in Christian Culture at the Catholic Information Center in Washington DC and is senior research fellow at the Faith & Reason Institute. A writer whose contributions to the intellectual landscape traverse genres, she is author of several non-fiction books including *How the West Really Lost God* and *Adam and Eve after the Pill.* Central to her diverse interests are questions concerning the fate and aspirations of post-modern men and women.

Anthony M Esolen, 63, is a writer, social commentator and professor

Legal scholar, political philosopher and intellectual

Robert George, 67, serves as the sixth McCormick Professor of Jurisprudence and director of the James Madison Program in American Ideals and Institutions at Princeton University. A legal and political scholar, he is considered one of the country's leading conservative intellectuals. He co-founded the American Principles Project, with funding from Sean Fieler, and is a past chairman of the National Organization for Marriage. In 2009, he was called the "most influential conservative Christian thinker" in the US by David Kirkpatrick of the New York Times. He has been awarded the Presidential Citizens Medal and. among other awards, the Canterbury Medal of the Becket Fund for Religious Liberty. He has chaired the US Commission on

International Religious Freedom. His admirers say he is renewing a philosophy of Catholic natural law thinking that goes back to St Thomas Aquinas.

George E Gunning

Executive director, Neumann Forum

George Gunning runs the Neumann Forum, a non-profit deciated to promoting and protecting traditional faith in Philadelphia. He has worked as treasurer at the Catholic Bioethics Center, committed to applying the moral teachings of the Catholic Church to ethical issues arising in healthcare and the life sciences. He graduated from Temple University, Philadelphia and used to work at the Catholic Foundation of Greater Philadelphia and Archdiocese of Philadelphia. He is also a former treasurer of the Archdiocese of New York.

Scott Hahn Theologian

Scott Hahn, 64, is a Catholic theologian and Christian apologist. A former Presbyterian who converted to Catholicism, Hahn is also the bestselling author of numerous books including The Lamb's Supper, Reasons to Believe and Rome Sweet Home. A popular speaker and teacher, Hahn has delivered numerous talks nationally and internationally on a wide variety of topics related to Scripture and the Catholic faith. His talks have been effective in helping thousands of Protestants and fallen-away Catholics to)embrace the Catholic faith. Hahn is married to Kimberly Hahn, who co-runs their Catholic apostolate, the St Paul Center for Biblical Theology.

Dean Koontz

Science fiction author

Dean Koontz, 77, is an American
 bestselling novelist whose books
 have sold over 500 million copies.

After being brought up in Pennsylvania by a "violent, alcoholic" father, he turned to reading as a way of escape and then writing books. They cross genres, combining horror, fantasy, science fiction, mystery, and satire. Seeing the Catholic faith as an antidote to the chaos in his family, Koontz converted in college because faith provided existential answers for life; he admired Catholicism's "intellectual rigour". saying it permitted a view of life that saw mystery and wonder in all things. "I want to extravagantly entertain readers," he says, "while making them feel the wonder of life and consider its profound mysteries." He shares the view of GK Chesterton that his writing is inspired by a "joy about the gift of life". He lives in Shady Canyon, California with his wife Gerda.

Larry Kudlow

Conservative TV host

Larry Kudlow was the 12th director of the National Economic Council in the Trump administration, serving from from 2018 to January 2021. A TV news host and commentator for the Fox network, he is a religious as well as a political convert. After being a left-wing activist, he became an economics adviser to the Reagan administration, serving two terms, and has been a leading Conservative economist ever since. He is the 2022 recipient of the William F Buckley Prize for leadership in political thought. While returning to Wall Street in the 1990s, he battled with addiction issues and converted to Catholicism with spiritual help from Father C John McCloskey III. He has served on the Catholic Advisory Board of the Ave Maria Mutual Funds and as a member of the Fordham University board of trustees.

Alasdair MacIntyre Philosopher

Alasdair MacIntyre, 93, is a

Scottish-American philosopher of moral and political philosophy as well as history of philosophy and theology. His After Virtue (1981) is one of the best-known works of 20th-century political philosophy. He is senior research fellow at the Centre for Contemporary Aristotelian Studies in Ethics and Politics at London Metropolitan University, emeritus professor of philosophy at the University of Notre Dame, and permanent senior distinguished research fellow at the Notre Dame Center for Ethics and Culture. MacIntyre converted to Catholicism in the early 1980s, and now does his work against the background of what he calls an "Augustinian Thomist approach to moral philosophy".

Ralph Martin

Author and president, Renewal Ministries

Ralph Martin, 80, is a "renewal movement leader" and author who addressed the UK Confraternity of Catholic Priests in York in 2022 (sponsored by the *Catholic Herald*). He is president of Renewal Ministries, a body devoted to Catholic renewal and evangelisation. He hosts *The Choices We Face*, a weekly Catholic television and radio programme with a global audience. He is also a visiting professor of theology at the Franciscan University of Steubenville.

Chad Pecknold

Professor of Theology, Catholic University of America

Chad Pecknold is a professor of theology at the Catholic University of America, in Washington DC. He is the author of *Christianity and Politics: A Brief Guide to the History, and The T&T Clark Companion to Augustine and Modern Theology.* A contributing editor to the *Catholic Herald,* he publishes regularly on the Church and modern politics in *First Things,* the *New York Times* and the *Wall* Street Journal. Pecknold is also the co-founder of *The Postliberal Order* and resident theologian at the Basilica of St Mary.

Ramesh Ponnuru

Conservative political pundit, journalist and thinker

Ramesh Ponnuru, 48 and living in Washington DC, is a conservative political pundit, journalist and thinker. He is the editor of the National Review, a columnist for Bloomberg View and a contributing editor to National Affairs. In 2015. Politico Magazine listed both him and his wife, April Ponnuru, as two of the top "Politico 50" influential leaders in American politics. Ramesh was raised by a Hindu father and a Lutheran mother. He was an agnostic for a time before converting to Catholicism. In 2006, he vigorously defended the Catholic basis for his pro-life stance saying: "If I didn't believe Catholic teachings were true, I wouldn't be a Catholic."

Tim Powers

Science fiction novelist

California resident Tim Powers, 71, is a science fiction writer. He has twice won the World Fantasy Award, for Last Call and Declare, and has also twice won the Philip K Dick Memorial Award. Reviewers have accused him of writing as a Catholic and Christian apologist. Powers has said that such criticism is as much against "organised religion" as Catholicism. He describes himself as a practising Catholic. The protagonist of his first novel, Epitaph in Rust (1976) escapes from a rural monastery into the "wilds of a future Los Angeles".

Stephen Rasche

Senior fellow, Religious Freedom Institute

Rasche is senior fellow at the Religious Freedom Institute for International Religious Freedom in Conflict Regions as well as an acclaimed documentary maker and author. His film, Francis in Iraq, about Pope Francis's 2020 visit to the persecuted Christians of Iraq, premiered earlier this year at New York's Sheen Center with an address by Cardinal Dolan. A graduate of Boston College, he has worked for 35 years in international business and humanitarian aid projects, including living in Irag. He was a founding officer of the Catholic University in Erbil in 2014 and has served as a representative to the Vatican Dicastery on Refugees and Migrants.

Roy Schoeman

Rov H Schoeman, 71, is an author who converted from Judaism to the Catholic Church. He is famous for his writings on Catholic-Jewish relations. Schoeman's most famous work is Salvation Comes from the Jews, in which he argues that Christianity is the completion of Judaism and invites Jews to convert to the Catholic faith. His other books include Honey From the Rock: Sixteen Jews Find the Sweetness of Christ and Judaism: From the Catholic Perspective. Schoeman taught theology at Ave Maria University and Holy Apostles College and Seminary, hosts a weekly Catholic radio show on Radio Maria and has a daily internet livestream.

Nicholas Sparks

Author and philanthropist

Nicholas Sparks, 56, is an author and philanthropist known for novels such as *The Notebook, Dear John* and most recently *The Wish.* His books have sold over 75 million copies in the United States alone. Sparks has donated to several local and national charities. He is a major contributor to the creative writing programme at his alma mater, the University of Notre Dame, and together with his wife, cofounded the Epiphany School in New Berne, North Carolina.

Adrian Vermeule Legal scholar

Adrian Vermeule, 54, is a Catholic convert and legal scholar who is currently the Ralph S Taylor professor of constitutional law at Harvard Law School. Vermeule is the author of eight books, including Law and the Limits of Reason. In 2012 he was elected to the American Academy of Arts and Sciences, Professor Vermeule is known for his advocacy of legal theories such as common-good constitutionalism and integralism, both of which seek to create a social order based on Catholic moral and social teaching.

George Weigel

Theologian and author

George Weigel, 71, is a worldleading Catholic theologian and author who is currently a distinguished senior fellow of the Ethics and Public Policy Center and holds the EPPC's William E Simon Chair in Catholic Studies. He has considerable influence in the Church. From 1986 to 1989, he served as the founding president of the James Madison Foundation. Weigel's articles have appeared in such publications as First Things, National Review and the Wall Street Journal, and he has made television appearances on NBC and ETWN. He is the author of 29 books including the bestselling biography of John Paul II, Witness to Hope. He is a member of the advisory council of the Victims of Communism Memorial Foundation, and he writes and serves on the board for the Institute for Religion and Public Life, Weigel and his wife Joan live in north Bethesda, Maryland. They have three children.

Lloyd Austin

United States Secretary of Defence

Lloyd Austin, 69, is a retired US Army four-star general who serves as the 28th United States secretary of defence. Nominated by President Joe Biden, he is the first African American to serve in that role. Austin was raised by a devout Catholic mother and remains practising.

Martin E Dempsey

General and former Joint Chief of Staff

Martin Edward Dempsey, 70, served as the 18th chairman of the Joint Chiefs of Staff and is a retired US Army general who also previously served as the Chief of





Staff of the Army. He attended John S Burke Catholic High School in New York and holds a master's degree in literature from Duke University, writing his thesis on the Irish literary revival. He has given a lecture on faith in geopolitics for the Duke Catholic Center at the Thomas International Centre.

Joseph Dunford

General and former chairman of Joint Chiefs of Staff

General Joseph Francis Dunford Jr, 66, served as the 19th chairman of the Joint Chiefs of Staff. the nation's highest-ranking military officer, and the principal military adviser to the president, secretary of defence and National Security Council from 2015 to 2019. A native of Boston, he graduated from Saint Michael's College and was commissioned in 1977. In 2020, he headlined the Celebration of the Priesthood dinner, an annual event that honours the nearly 540 active and senior priests in good standing across Greater Boston.

Mark Milley

Chairman of the Joint Chiefs of Staff

Mark Milley, 64, has served as the chairman of the Joint Chiefs of Staff of the US Armed Forces since his appointment by Donald Trump in 2019. He previously served as the 39th chief of staff of the Army from 2015 to 2019, and held multiple command and staff positions in eight divisions and special forces throughout his military career, serving in Bosnia-Herzegovina, Iraq and Afghanistan. Milley is of Irish descent and was raised in a Catholic family.

Sports & Entertainment

Simone Biles

Olympic gymnast

Simone Biles, 25 and a resident of Texas, having won 25 World Championship medals, is considered by many to be one of the greatest gymnasts of her era. Her seven Olympic medals tie her for the most Olympic medals won by an American gymnast. In 2022 she was awarded the Presidential Medal of Freedom by Joe Biden. Biles is a practising Catholic who has written and spoken about the importance of faith in her life, about praying the Rosary and the Hail Mary and also on how she lights a candle to St Sebastian, patron saint of athletes, prior to competitions.

Matt Birk

Former NFL great, politician and philanthropist

Matthew Birk, aged 46, is a former NFL player whose career spanned 14 seasons. He spent most of this time playing for the Minnesota Vikings. Before beginning his career in the NFL, Birk graduated from Harvard University in 1998 with a degree in economics. He is currently the Republican nominee for lieutenant governor of Minnesota, running in the 2022 Minnesota gubernatorial election. In 2019. Birk founded a private Catholic high school in his home town of Burnsville, Minnesota. He is an outspoken critic of abortion and same-sex marriage.

Pierce Brosnan Actor

 Pierce Brosnan, 69, the Irish-born
 g star of James Bond films and

Mamma Mia!, lives today in Hawaii with his second wife Keely. After his first wife Cassandra Harris died from ovarian cancer in 1991, he spoke out about how important his faith is to him. A former altar boy, he was brought up by his mother and educated by the Christian Brothers. He stated: "My faith has been good to me in the moments of deepest suffering, doubt and fear. It is a constant, the language of praver."

Harrison Butker

Kansas City Chiefs placekicker

Harrison Butker, 27, is an NFL placekicker for the Kansas City Chiefs. In 2019 he led the NFL in scoring and won a Super Bowl with Kansas City. He has been outspoken on Catholic issues. He publicly argued against *Traditionis Custodes* on the basis that he felt tradition-orientated Catholics were neglected by the Church. In 2022, Butker supported the Kansas Value Them Both Amendment, which aimed to overturn the ruling that the Kansas constitution guarantees a right to abortion.

Jim Caviezel Actor

James Caviezel Jr, 53, is a film and television actor who most significantly played Jesus Christ in *The Passion of the Christ*. He has had many other notable roles, such as that of Edmund Dantès in *The Count of Monte Cristo* and John Reese in *Person of Interest*. He was raised in a very close Catholic family in Washington state and has been a featured public speaker at numerous religious venues since the release of *The Passion of the Christ.* In 2005 he acted as the spokesman for the first Catholic Men's Conference in Boston.

Christine Evert Former tennis professional

Chris Evert, 67, is an American former world No 1 tennis player who wore a crucifix when she played on court. Evert won 18 major singles titles, including a record seven French Open titles and a joint-record six US Open titles. Evert dominated women's tennis in the 1970s and 1980s and reached 34 major singles finals. She was awarded the Philippe Chatrier award and inducted into the Hall of Fame. In later life, Evert was a coach and is now an analyst for ESPN. Raised in a committed Catholic household, she is a 1973 graduate of St Thomas Aguinas High School in Fort Lauderdale. She has been married three times, to British tennis player John Lloyd, US skier Andy Mill and Australian golfer Greg Norman. In 2013, Jimmy Connors revealed in his memoir that an abortion was the reason their marriage was called off in 1974. Since 1989, Chris Evert has contributed over \$26 million in an ongoing campaign against drug abuse and child neglect in Florida. She continues to raise money to fund programmes that ensure a bright future for at-risk children and their families.

Brett Favre Former NFL quarterback

Brett Favre, 52, is a former quarterback who played primarily with the Green Bay Packers. His career spanned 20 years and from 1995 to 1997 he was named Most Valuable Player three years in a row, the most the award was consecutively received by any player in history. At the time of his retirement, Favre was the NFL leader in passing yards, passing touchdowns and quarterback wins. Favre credits his Catholic faith for its influence in shaping and helping him face adversity throughout his life. The Brett Favre Fourward Foundation has donated more than \$2 million to charities in Mississippi and Wisconsin.


Marcus Freeman

Head coach, Notre Dame University

Marcus Freeman is an American football coach who has gained fame as the second African American head coach for the University of Notre Dame. He briefly played as a line-backer in the NFL before retiring in 2010 due to an enlarged heart condition; since then he has found success as a coach for an array of college football teams. Freeman became a Catholic earlier this year at St Pius X Church in Granger, Indiana.

Jimmy Kimmel

James Kimmel, 54, is a TV host, comedian and producer. He is the host and executive producer of *Jimmy Kimmel Livel*, a late-night talk show that premiered on ABC on 26 January, 2003. In 2018, *Time* named him as one of the world's 100 most influential people. She was a USA Olympic team member in 2012, 2016 and 2020, and holds the female record for most individual gold medals (14) and overall gold medals (19) at the World Aquatics Championships. Her combined 20 individual titles at the Olympics (six) and World Aquatics Championships (14) is also a record for female swimmers. Ledecky is a devout, actively practising Catholic. She credits her faith to a strong Catholic formation, which included attending Little Flower Catholic School and Stone Ridge School of the Sacred Heart.

Joe Montana

Former NFL quarterback

San Francisco resident Joe Montana, 66, is a former NFL football player who played for the San Francisco 49ers and the Kansas City Chiefs. He is regarded as one of the greatest quarterbacks of all time. During his career, Montana won four Super Bowls and was the first player to be named Super Bowl Most Valuable Player three times. In 2000, he was inducted into the Pro Football Hall of Fame. Montana comes from an Italian Catholic family, his surname having been anglicised from the Italian Montani. He attended the University of Notre Dame where he played football, and his children attended De La Salle High School near San Francisco. He has generously

Conan O'Brien TV host

A DNA test in 2019 revealed that he is 100 per cent Irish.

Mike Piazza Former MLB player

Mike Piazza, 54, is a former baseball player who played for the New York Mets and the Los Angeles Dodgers. In 2013, he was inducted to the New York Mets Hall of Fame, and in 2016 he was elected to the Baseball Hall of Fame. Piazza manages the Italian national baseball team. He is a devout Catholic and appeared in the documentary *Champions of Faith*, which explored the intersection between the faith and sports.

Theo Sarandos

Co-CEO and chief content officer, Netflix

Theodore Sarandos, 58, is the co-CEO and chief content officer of Netflix. He was involved in the production of dramas such as *House of Cards*. He previously held many senior positions at several video distribution firms including Arizona Video Cassettes West, East Texas Distributors and West Coast Video. He comes from a Greek Catholic background and identifies as a Catholic.

Scottie Scheffler Golfer

Scott Scheffler is a professional

Martin Scorsese Director

Martin Scorsese, 79, is a film director, producer, screenwriter and actor. He is the recipient of many accolades. Silence, his 2016 production, follows two 17th-century Jesuit priests as they travel from Portugal to Japan in an attempt to spread Catholic Christianity. Scorsese had identified as lapsed; however in 2016, following the release of the film, he seemed to reaffirm his faith when he stated: "I am most comfortable as a Catholic. I believe in the tenets of Catholicism." He is widely considered to be one of the greatest influences on modern cinema.

Martin Sheen Actor

Martin Sheen, 82, is an actor bestknown for roles in films and TV shows such as Apocalypse Now, Gettysburg, The West Wing, Grace and Frankie and The Way. He was raised Catholic but fell away from the faith in his early career. He returned to the faith in 1981, yet he later described himself as Catholic only in a spiritual sense. Sheen supports the Catholic Worker Movement and the consistent life ethic, therefore opposing abortion, euthanasia and capital punishment

Jordan Spieth Golfer

Jordan Spieth, 29, is an American brofessional golfer on the PGA Tour


and former world number one. Having won three major titles and the 2015 FedEx Cup so far, he has accrued \$53 million in tournament earnings in his young career. He was born and raised in a Catholic family and attended St Monica's Catholic School and Jesuit College Prep in Dallas.

Bruce Springsteen Singer, musician

Bruce Springsteen is a singer, songwriter and musician. He has sold more than 150 million records worldwide and more than 64 million albums in the United States, making him one of the world's bestselling artists. He has earned numerous awards for his work, including 20 Grammys, two Golden Globes, an Academy Award and a Special Tony Award. His best-known albums include Nebraska, Born in the USA, The River and Born to Run. Springsteen was also awarded the Presidential Medal of Freedom by President Obama in 2016. Born into a Catholic family, Springsteen attended the St Rose of Lima Catholic school in Freehold, New Jersey. "It's pretty overt," Springsteen has said of Catholicism in his work. "It informed my language." For Springsteen, this Catholic language was informed by the Latin Mass, in which he participated as an altar boy. Nick Ripatrazone wrote for the Catholic Herald in 2021: "For one born and raised in the faith like Springsteen, there's no leaving it behind. From his first album to his latest, Springsteen has confessed to the congregation: he's a sinner. His songs are his penance, and the beauty of such art is that we get to feel the hardworn grace ourselves."









Ben Steele NFL coach

Benjamin Steele, 44, is a former tight end for Green Bay Packers and offensive line coach for the Denver Broncos in the NFL. Steele played college football at Fort Lewis College and Mesa State College. He is a devout Catholic who encourages his men to be champions of the Rosary on and off the field.

Douglas Urbanski Film producer

Douglas Urbanski, 65, is an American film producer. He has been nominated twice for an Oscar, once for a Golden Globe and has won a BAFTA for motion picture producer. In addition to his Academy Award-winning films Darkest Hour and Mank, along with his other films, Tinker Tailor Soldier Spy, The Contender and Nil By Mouth, his films have received 21 Oscar nominations, ten Golden Globe nominations and 33 BAFTA nods. He serves as a Eucharistic minister at St Victor's in West Hollywood.

Eduardo Verástegui Actor

Eduardo Verástegui. 48. is a Mexican-born actor who has appeared in CSI Miami, See You in Miami and Paul Blart: Mall Cop 2. Raised in a Catholic family, he rediscovered the faith through the example of his English-language coach. He is committed to going to Mass daily, reading the Bible, saying the Rosary and going to Confession once a week. He

voiced Jesus in the Spanish dubbing of Son of God. He is actively involved in the pro-life cause through his movement Manto de Guadalupe.

Mark Wahlberg Actor

Mark Wahlberg, 51, is an actor, producer and director of many films. He co-funded the recent religious movie Father Stu. about a boxer turned priest, in which he stars with Mel Gibson. Wahlberg is also the executive producer of several series on HBO, including Entourage, and the co-owner of the Wahlburgers fast food chain. He has stated that the Catholic faith is the most important part of his life. He is active at the Good Shepherd Center for homeless women and children in LA.

Justice and peace coordinator, Catholic Charities of Archdiocese of New York



As such, Shriver was raised Catholic and received his master's from the Catholic University of America.

Marcela Szymanski

Advocacy officer, Aid to the Church in Need

Marcela Szvmanski lives in Brussels. Since 2011 she is the EU and UN advocacy officer for the pontifical foundation Aid to the Church in Need, which helps the voice of the persecuted Church to be heard among policy-makers. She conducts high-level public diplomacy relations on behalf of persecuted Christians, including kidnapped priests as well as entire communities under duress by the Islamic State. She often appears on TV shows defending the importance of maintaining the integrity of Article 18, promoting and protecting the right to freedom of thought, conscience and religion, and opposing attempts to separate its basic elements.

Elizabeth Yore

Child advocacy attorney

The founder of Yore Children, Elizabeth Yore is a child advocacy attorney who deals with legal issues relating to the exploitation of children. She served as special counsel to Oprah Winfrey as her child advocate, both at Harpo and at the Oprah Winfrey Leadership Academy for Girls in South Africa. In addition, Yore served as general counsel at the Illinois Department of Children and Family Services.

Mavericks

Conrad Black Broadcaster and commentator

Conrad Black, 78, is a Canadianborn British businessman who, in the 1990s, built Hollinger International which was once the world's third-largest Englishlanguage newspaper empire. Although Canadian, Black's brilliant and prolific US journalism and books make him an honorary literary citizen. Raised in an atheistic family, it took time for Black to find his faith. He explained that he "approached Rome at a snail's pace" until he was eventually received into the Roman Catholic Church in 1986 by Gerald Emmett Cardinal Carter. In 2001, Black was invested as a knight commander of the Order of St Gregory the Great, a papal order of chivalry awarded by Pope John Paul II.

Mel Gibson

Actor, producer and director

Mel Gibson, 66, is an actor, director and producer. Best known for his roles in *Mad Max* and *Lethal Weapon*, his career took a different direction when he directed, produced and co-funded



biblical drama that has made \$612 million worldwide. Gibson was raised a devout sedevacantist traditionalist Catholic, although Fr William Fulco said in 2009 that Gibson denies neither the pope nor Vatican II. He is a friend of the actor Mark Wahlberg with whom he starred in Father Stu, about a boxer turned priest. He has given millions of dollars to many causes including the Mirador Basin project, Healing the Children and alcohol and drug education. "Philanthropy gives you perspective. It's one of my faults, you tend to focus on yourself a lot. You take a little time out to think about other people - it's good. It's uplifting."

The Passion of the Christ, a 2004

Mickey Rourke

Although he claimed he was blacklisted by Hollywood for around 14 years for being difficult to work with, Mickey Rourke has always had a strong connection to his Irish-rooted faith. He has starred in faith-based films including *A Prayer for the Dying* (1987), in which he plays an IRA hitman who develops a bond with a Catholic priest. The former boxer recently

played a paralysed man in Man of God, about a Greek Orthodox saint who establishes a covenant for pilgrims on a desolate island. He savs he owes his career comeback to Father Peter Colapietro, a priest at Holy Cross Church in New York, who "saved him" after he was in a dark place. "I would talk to Father Peter on weekends." Rourke told Fox News. "And I would tell him, 'I'm not gonna pray anymore.' One day, he looked at me and said, 'Mickey, nobody gets a pass.' One thing I've learned is that everything's in God's hands."

Keeping the faith

The Catholic Herald Institute is a new Mid-Atlantic think-tank aiming to renew Catholic identity and influence the Church. By **Jamie MacGuire**

oday the future of Catholic identity in the US and UK depends more than ever on leadership and example from an active and committed laity. This is not simply a result of declining numbers of those in religious life, or scandals. It is because the most dynamic agents of social progress today emanate from civilian leadership in philanthropy, business, politics, law and justice, technology, media, government, entertainment and sport.

By identifying the 250 most influential Catholic lay figures across America today, we hope to stimulate a reinvigorated spiritual dimension in an increasingly secular society. To assist in this process of renewal, the Herald is launching the Catholic Herald Institute, a dynamic new Mid-Atlantic think-tank, based in NYC and London, initiative devoted to defending and promoting Catholic values and identity in public life especially the family. We have set an annual budget of \$300,000 and are seeking anchor donors to support our Herald Institute fellowship programme of writers around the world. The Herald has 134 years of intellectual history behind it and few non-profits have our influence in the public piazza.

The division in the Church is now increasingly a battle for the very soul and future of the Catholic faith. The Church is facing its largest crisis since the Second Vatican Council. This, however, has created the Catholic media's greatest opportunity for digital engagement. Our vision is to use the Institute to complement our magazine so that we become thought leaders in the trenches of today's cultural, political and religious debate. Having such an influential magazine – read from the Vatican to Capitol Hill – as a multimedia platform for our views makes us unique.

We aim to reverse the negative statistics (13 per cent of Americans now say they are "ex-Catholic"), messaging and indifference through positive thought-leadership that promotes our spiritual and intellectual mission based on the three pillars of the faith: family, human dignity and human life. The family is the most important bulwark against the state. We also uphold the Western tradition of culture and faith and support the idea of a morally rooted culture and society that believes in freedom of responsibility and democratic government.

This secular crisis of belief lies in the culture of the Church itself – a culture of lost belief. Priests across America worry as little as 50 per cent of their congregations have returned to parish worship after the pandemic. This is partly because Catholic institutions and many priests are not interested in having this public debate or fighting intellectually to preserve Catholic values.

Hence why we are taking the challenge on. I have the honour of being asked to lead its American branch as US senior director and trustee. Over a decade ago I conceived and founded the Portsmouth Institute (portsmouthinstitute.org) at Portsmouth Abbey School in Rhode Island, which has flourished on a regional level, and I remain its emeritus director. I founded the Portsmouth Institute to strengthen the Catholic identity of Portsmouth Abbey School at a time when our monastery was aging and diminishing, and the lay faculty was becoming more secular. We held conferences celebrating the beatification of Cardinal Newman, and debated the intriguing question of Shakespeare's Catholic religious identity, the complementary nature of science and religion, and Catholicism as an integral component of the American Experience.

Along the way we staged plays in churches, hosted concerts and sponsored research studies abroad. At the Herald Institute, we will programme similar events on a larger scale, including patrons' pilgrimages - such as the Herald's memorable Santiago de Compostela walking pilgrimage - and produce podcasts, documentaries and host lectures and speaker dinners. We have already hosted several events in New York, including a debate on the crisis of the Church today between Rusty Reno, editor of First Things, and Herald contributor Father Gerald Murray, and a VIP dinner following the world premiere of the documentary Francis in Iraq at New York's Sheen Center for Thought & Culture.

We will be inviting business leaders and philanthropists to support us as

we speak out on the most consequential issues of our time and safeguard Catholic values for generations to come, just as we have since 1888. Our vision is to use the *Herald*'s record of outstanding Catholic thinking – with writers including GK Chesterton,

JRR Tolkien, Evelyn Waugh and Graham Greene – as the foundation

for society-changing intellectual leadership. We will take advantage of all of today's global digital engagement and multimedia opportunities to lead the Catholic conversation. We hope our readers and America's Catholic leaders will support us in our battle and journey ahead. CH
